1. THIS AGREEMENT IS FOR, **SATURDAY, AUGUST 26, 2017**. IF THE EVENT IS CANCELLED DUE TO RAIN, VENDORS WILL BE NOTIFIED THE MORNING OF EVENT BY PHONE AND A FULL REFUND WILL BE ISSUED.
2. RENTAL SPACE IS TO BE PAID IN FULL AND SUBMITTED WITH THIS SIGNED CONTRACT.
3. RENTAL SPACE IS UNDER THE CONTROL OF THE BECKEMEYER COMMUNITY DEVELOPMENT CLUB, THE VILLAGE OF BECKEMEYER AND THE LITTLE PIG COOKOFF COMMITTEE.
4. RENTAL SPACE IS AN OUTDOOR SPACE, APPROXIMATELY 10X10. LIMITED ELECTRICITY IS AVAILABLE.
5. COST IS \$20 PER SPACE. ELECTRICITY IS AN ADDITIONAL \$5 AND OFFERED AS FIRST COME, FIRST SERVED. A \$10 DISCOUNT WILL BE GIVEN WITH DONATION OF A \$10 RAFFLE ITEM (RETAIL VALUE). RAFFLE ITEMS WILL BE COLLECTED AT SIGN IN ON THE DAY OF THE EVENT.

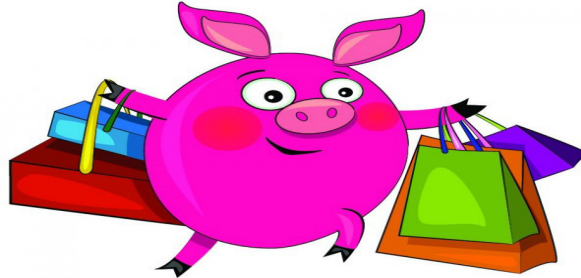
